

# PUBLIC NOTICE

## DEPARTMENT FOR TRANSPORT

### TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State gives notice of the proposal to make an Order under section 247 of the above Act to authorise the stopping up of a part width of A4 London Road adjacent to The Pewsham Public House at Chippenham, in Wiltshire.

If made, the Order would authorise the stopping up only to enable development to be carried out should planning permission be granted by Wiltshire Council. The Secretary of State gives notice of the draft Order under Section 253 (1) of the Act.

Copies of the draft Order and relevant plan will be available for inspection during normal opening hours at Chippenham Town Council, Town Hall, High Street, Chippenham Wiltshire SN15 3ER in the 28 days commencing on 22 December 2022, and may be obtained, free of charge, from the addresses stated below quoting NATTRAN/SW/S247/5279.

**TOWN AND COUNTRY PLANNING ACT 1990**

**THE STOPPING UP OF HIGHWAY (SOUTH WEST) (NO. ) ORDER 20..**

The Secretary of State makes this Order in exercise of powers under section 247 of the Town and Country Planning Act 1990 ("the Act").

1. The Secretary of State authorises the stopping up of the highway described in the Schedule to this Order and shown on the plan numbered NATTRAN/SW/S247/5279, to enable development to be carried out in accordance with the planning permission granted by Wiltshire Council, under reference.....
2. Where immediately before the date of this Order there is any apparatus of statutory undertakers under, in, on, over, along or across any highway authorised to be stopped up pursuant to this Order then, subject to section 261(4) of the Act, those undertakers shall have the same rights as respects that apparatus after that highway is stopped up as they had immediately beforehand.

**THE SCHEDULE**

**Description of highway to be stopped up**

The highway to be stopped up is at Chippenham in Wiltshire, shown on the plan as a western part width of the A4 London Road. It commences 3 metres north east of the north eastern corner of The Pewsham Public House and extends in a south easterly direction for a maximum distance of 102.2 metres and has a maximum width of 13.3 metres.
