THE STOPPING UP OF HIGHWAY (SOUTH WEST) (NO. 04) ORDER 2023

The Secretary of State makes this Order in exercise of powers under section 247 of the Town and Country Planning Act 1990 ("the Act").

- 1. - 2. Where immediately before the date of this Order there is any apparatus of statutory undertakers under, in, on, over, along or across any highway authorised to be stopped up pursuant to this Order then, subject to section 261(4) of the Act, those undertakers shall have the same rights as respects that apparatus after that highway is stopped up as they had immediately beforehand.
- 3. This Order shall come into force on 02 March 2023

Description of highway to be stopped up
