Jennie Shaw representative of the Bobby van trust gave a basic overview into the work of the charity and the new project that they are requesting funding for.

Councillors asked a number of questions relating to the project and access to the project, if further funding would be required and what happens if the resident helped moves house.

**Proposal**; make a grant of £520 for initial roll out of video doorbells in our parish.

It was unanimously resolved to support the grant application for £520 to support the digital doorbell project.

A representative of Derry Tots provided a background to the group and the grant application.

The councillors asked a number of questions around reserves held, size of proposed shed and queries about if the hall would be charging increased storage costs for the additional storage provided. It was acknowledged that the councillors were supportive but required clarification.

Is there still a second reserves account held by the group?

Will the group be paying additional storage costs for the additional space.

The councillors discussed the amended plans at length and the outstanding issues from the last set of comment submitted.

**Proposal:** reiterate our support to the development and previous comments still stand and note that visibility issue hasn't been fully resolved. Ask highways to ask the developer to pay for the surface treatment on the road as per the substantive highways scheme to assist with reducing speed of cars.

And that the condition should ensure that where full visibility can be achieved it should be.

The proposal was approved by Majority with 1 abstention.

# 487/24. Update from Neighbourhood Plan,

Cllr Barnes provided a verbal update;

Still at examination stage, hoping to get report shortly. Wiltshire Council then receive report and decide if they will make modifications, this can take up to 5 weeks, hoping to get a decision around Christmas, reg 18 consultation 6 weeks period, then 4 week period into referendum, hope to get referendum in by mid march, hope to get in before pre election period for the local elections.

When examiner report received, need to be fact checked and create an information statement prior to referendum, which will be a yes or no vote on accepting the plan.

# 489.1/24 Calne Area LHFIG Meeting 1st November 2024

To consider the <u>report</u> from the Calne Area LHFIG Meeting of 1<sup>st</sup> November 2024.

The report was discussed and noted.

#### 489.2/24 Substantive Highway Schemes

To read the <u>report</u> and consider the Petty Lane to A4 Shared Use Path design and the Traffic Management at Derry Hill designs, both prepared by Wiltshire Council and to:

- Endorse their submission by Calne Area Board as a bid for Substantive Highways Scheme Funding in 2025/26.
- Agree the Council's contribution towards the estimated costs.

**Recommendation:** that the Council endorses the <u>Petty Lane to A4 Shared Use Path design</u> for submission by Calne Area Board as a bid for Substantive Highways Scheme Funding and agrees the Council's contribution towards the estimated cost of £71,625.45.

**Budget:** Infrastructure (to be funded from CIL Reserve).

Power: Highway act 1980, ss43, 50

**Recommendation:** that the Council endorses the <u>Traffic Management at Derry Hill design</u> for submission by Calne Area Board as a bid for Substantive Highways Scheme Funding and agrees the Council's contribution towards the estimated cost of £61,357.94.

**Budget:** Road Safety Budget (to be funded from CIL Reserve).

Power: Road Traffic Regulations Act 1984 S72.

Cllr Barnes outlined the substantive scheme process and background to the applications. It was noted that the Calne area board had not put forward a substantive scheme for a number of years. It was acknowledged that the higher the contribution a PC would put forward he higher the chance of a successful bid.

The councillors discussed the bids at length before making proposals relating to each proposed scheme

Proposal; Endorse both schemes and make contributions £25679 on Derry Hill and Studley Traffic calming scheme to take the parish council contribution up to 50%

It was resolved by majority to endorse both schemes and offer a contribution of £25679 for the traffic calming scheme for Derry Hill and Studley substantive scheme bid.

Proposal; Endorse shared use path and contribution of £16488 to take up to 30% contribution for the Petty Lane to A4 shared use path.

It was resolved by majority to offer a contribution of £16488 for the Petty Lane to A4 shared use path substantive scheme bid.

## 489.3/24 Studley Speed Limit

To note the Council's previous decision (minute 468.3/24) to authorise a contribution of up to 50% of the estimated cost of £9,000 to implement a 20mph Speed Limit in Studley, and to note that LHFIG has agreed to contribute 70% towards the cost, reducing the Council's commitment to £2,700.

The council noted the reduced contribution.

#### 489.4/24 Stockley, Broads Green and Heddington Speed Limits

To consider and note the attached <u>Briefing Note</u>, prepared by Wiltshire Council in response to the Council's request for Speed Limit changes around Stockley, Broads Green and Heddington.

The council noted the briefing note.

# 489.5/24 Chilvester Hill Bus Shelters

Following the Council's previous decision (minute 468.2/24) to authorise a contribution of up to 50% of the estimated cost of £10,486 to provide and install two bus shelters on the A4 at Chilvester Hill, to note that LHFIG are unable to provide funding from the 2024/25 budget which has now been almost fully allocated, and to defer any further funding decision to the December meeting to allow Wiltshire Highways to clarify any additional traffic management requirements.

IR reported possible additional costs likely due to potential additional traffic management costs.
