**693/25. Forest gate community fund agreement-**

The draft document was discussed.

There was a discussion about the 'area of benefit'

Following discussion the following proposal was made;

It is proposed to change the 'area of benefit' to be only Derry hill & Studley Parish Council and remove the surrounding communities from the clause. Using the boundary as defined by Wiltshire Council.

**4 voted in favour of the proposal and 4 voted against the proposal.**

Cllr Barnes as chairman of the meeting used his casting vote to vote against the proposal.

*It was resolved by majority not to amend the area of benefit as drafted.*

There was a further discussion about the definition of net capacity of the farm and to request that this was included in the document.

*It was unanimously resolved that subject to the amendments discussed that the agreement is accepted.*

**694/25 Update from the Footpaths Group.**

To receive a verbal update from the footpaths and rights of way working group.

Footpaths group have surveyed all the rights of way, there is 26 paths in the parish which amounts to 16.9 miles of paths, found 18 issues and 9 places that require regular maintenance, there also appears to be one footpath that has 'disappeared' Contact now to be made with the landowners to discuss the next steps to be taken.

The working group will bring a report to the next council meeting (Feb 26) with any maintenance works required.
